No ball caps. 60 sec time limit on warmups. Pre-entries accepted. Warmups will be pre-sold. Pre-entries, warmups and reservations taken with payment.

*Multi-age class is a combination of Youth, Adult, and Masters. It will be ran as a single class and split up upon completion. Added money in multi-age class will be split equally between youth, adult, and masters upon completion. Entry fees include \$2 award fees (except PeeWee & Futurity) Paybacks calculated after awards fees deducted: 75% Open barrels; 90% futurity sidepot; 70% all other classes.
